ALL new businesses **MUST** complete an Industry Information Questionnaire. Further Applications may or may not be required; determination is based on the facility type.

All New Businesses:

Industry Information Questionnaire: All new business and construction of new buildings in PCWRA's service area are required to complete and submit the Industry Information Questionnaire (IIQ). This is a preliminary application. Additional application(s) may be required.

Dental Amalgam Application: All new Dental Facilities are required to complete the IIQ and a Dental Amalgam Application (DAA). The link to the online DAA will be emailed to the applicant upon review of the IIQ. In addition to the DAA, the applicant needs to provide the following:

- \$100 review fee
- Construction drawings of the facility and of the amalgam separator

Food Service Establishments

Food Service Application: All new Food Service Establishments are required to complete the IIQ and a Food Service Application (FSA). The link to the online FSA will be emailed to the applicant upon review of the IIQ. In addition to the FSA, the applicant needs to provide the following:

- \$200 review fee
- Dated copy of a menu
- Construction drawings of the facility and of the oil/grease interceptor

Petroleum, Oil, Grease & Sand Facilities

Petroleum, Oil, Grease & Sand Application: All new Petroleum, Oil, Grease & Sand Facilities are required to complete the IIQ and the Petroleum, Oil, Grease & Sand Application (POGSA). The link to the online POGSA will be emailed to the applicant upon review of the IIQ. In addition to the POGSA, the applicant needs to provide the following:

- \$200 review fee
- Construction drawings of the facility and of the sand/oil interceptor

Industrial Facilities

Industrial Waste Application: All new Industrial Facilities are required to complete the IIQ and the Industrial Waste Application (IWA). The link to the online IWA will be emailed to the applicant upon review of the IIQ. In addition to the IWA, the applicant needs to provide the following:

- \$100 review fee
- Construction drawings of the facility



Note for Developers:

PCWRA requires all new commercial buildings to provide a stub-out for a separate waste line for future interceptor installation.
